POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 30 MAY 2018

References are made to the notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) and the circular (the “**Circular**”) of North Mining Shares Company Limited (the “**Company**”) both dated 26 April 2018. Terms defined in the Notice and the Circular shall have the same meanings when used herein.

RESULTS OF THE AGM

The Board of the Company is pleased to announce that the AGM was duly held on 30 May 2018 during which all resolutions stated in the Notice were duly passed by the shareholders by way of poll at the AGM. Tricor Tengis Limited, the Company’s share registrar, acted as the scrutineer for the purpose of vote-taking at the AGM.

As at the date of the AGM, there were 21,495,386,286 shares of the Company in issue, which was the total number of shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no shares entitling the holders to attend and vote only against the resolutions at the AGM.
