INSIDE INFORMATION UPDATE ON WINDING UP PETITION IN HONG KONG

This announcement is made by North Mining Shares Company Limited (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

Reference is made to the announcements dated 12 July 2019, 25 July 2019, 21 August 2019, 26 August 2019, 30 September 2019, 14 October 2019, 30 October 2019, 3 November 2019 and 4 November 2019 (the “**Announcements**”) of the Company in relation to, among others, the Petition in Hong Kong, the winding up petition and the application for appointment of provisional liquidators for restructuring purposes in the Bermuda Court. Capitalised terms in this announcement have the same meanings as those defined in the Announcements, unless the context requires otherwise.

The Company wishes to update the shareholders and potential investors of the Company that at the first hearing of the winding up petition before the Bermuda Court on 15 November 2019, Justice Subair Williams granted an adjournment of the petition to 31 January 2020 in order to allow time for the joint and several provisional liquidators to prepare a report on the restructuring progress of the Company.

The Company will keep its shareholders and potential investors informed of any significant development of the Petition and will make further announcement(s) on the progress of the Petition as and when appropriate in accordance with the Listing Rules.
