FURTHER DELAY IN DESPATCH OF CIRCULAR

References are made to the announcements (the “**Announcements**”) of North Mining Shares Company Limited (the “**Company**”) dated 22 December 2020, 31 December 2020 and 12 January 2021 in relation to, among other things, the Subscriptions by Huatuan and SFund International of the Convertible Notes, the Promissory Notes and the Penalty Notes and the proposed Authorised Share Capital Increase.
